Sub: - Complaint against Niranjn Roy (40 Yrs) S/O- Lt. Jihur Roy of Vill- Kulgora, PS- Hura, Dist- Purulia to start a cog case U/S-46A(c) B.E. Act.

Sir,

In producing here with arrested accused namely Niranjn Roy (40 Yrs) S/O- Lt. Jihur Roy of Vill- Kulgora, PS- Hura, Dist- Purulia along with seized one white colour plastic container containing approx 10 (ten) ltrs. ID liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 10.12.2021 at 16:05 hrs. received a credible source information from my reliable source that the above noted accd. person was stoking and selling Id liquor at Kulgora village. Accordingly I informed the matter to O/C Hura PS and as per his direction I ASI Narayan Mukharjee along with force vide Hura PS C.C. No.- 3324/21 date- 10.12.21 left for work out that information. After reaching to spot along with force and held raid in between (16:25 hrs. & 17:25 hrs) in the house of above noted accused person at Kulgora village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling ID liquor which was kept in his house at Kulgora under Hura PS, Dist Purulia. On demand, he failed to produce any valid documents/ License in respect of selling and stocking ID liquor. Accordingly, I seized one white colour plastic container containing approx 10 (ten) ltrs. ID liquor & five empty plastic glass after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle approx 500 ML. Then I arrested him U/S- 67 B.E. act. after preparing proper Arrest Memo, maintained all formalities regarding arrest as he committed offence U/S 46A(c) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers left the place.

Under the above fact circumstances and, I therefore pray that a Cog. Case U/S 46A(c) B.E Act may kindly be started against the arrested accused person Niranjn Roy (40 Yrs) S/O- Lt. Jihur Roy of Vill- Kulgora, PS- Hura, Dist- Purulia and arrange for its investigation.
