Sir,

In producing herewith one arrested accused namely Sisir Kr Hansda @ Majhi(37),s/o-Lt Kailash Ch Majhi@ Hansda of Vill-Palashkura, PS-Para, Dist- Purulia with Arrest Memo, seizure list, other related papers and seized articles such as one iron made single bore country made firearms having length of 25 cm (approx) with butt, barrel, firing pin, trigger etc. The length of the barrel is 15 cm (approx) and one live ammunition of 8 mm under proper seizure list and being labeled properly, I beg to inform you that today (12/12/21) during my mobile duty at Hura PS area vide Hura PS CC No- 3341 Dtd-12/12/21 & GDE No- 675 Dtd-12.12.2021 at 16:15 hrs received a telephonic information from my reliable source that one youth aged about 35 years was seen loitering at Saldiha more under Hura PS and a careful observation from the close point of view something like the butt of a small firearms was seen at his waist being kept supported with his pant and it was his firm belief that it was nothing but a fire arms . I asked him to keep eye upon the suspicious person and consulted with O/C Hura PS over telephone about this matter and as per his direction at 16:25 hrs, I along with C/1052-Shyamlal Murmu, HG/1449-Mithun Majhi of Hura PS started for working out the information from Ladhurka more after briefing them properly about the gravity of the information and my plan to nab him. We reached at Saldiha more at around 16:45 hrs and keeping the vehicle parked in a safe place we proceeded to the spot on feet. On reaching there, my source identified the person by gesture from a distance and we apprehended one youth and on asked he identified himself as Sisir Kr Hansda @ Majhi (37),s/o-Lt Kailash Ch Majhi@ Hansda of Vill-Palashkura, PS-Para, Dist- Purulia and I disclosed him about the information and on searching one iron made single bore country made fire arms having length of 25 cm (approx) with butt, barrel, firing pin, trigger etc has been found. The length of the barrel is 15 cm (approx) and was recovered from his exclusive possession and on opening the fire arms one live ammunition of 8 mm was recovered as being loaded in the fire arms. On asked he failed to produce any constitutional papers in support of possessing or keeping the fire arms. I seized the above narrated firearms and ammunition from his possession under proper seizure list and also labeled them separately in between 16.55 hrs & 17.25 hrs, but no public witness could be made available there on that time. After seizure I arrested him at 17.35 hrs observing all the formalities regarding arrest as his offense comes under the purview of Indian Arms Act.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
