The Inspector In-Charge Jhalda P.S. Dist. Purulia

Sir,

I, SI- Asoke Kr. Sen along with force returned to PS and brought under seizure approx 02 Ton steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (24/25.12.2021) at night I along with force namely i) C/1207 Tarit Kr. Majhi ii) C/1484 Kajal Kr. Nayek iii) NVF/039 Lalit Kishor Mahato iv) HG/1681 Manmotha Kumar were performing night mobile duty in PS area vide Jhalda P.S. GDE No- 1047 Dated- 24/12/2021 in consonance with Jhalda PS CC No- 4979/21 Dated- 24/12/2021. During my night mobile duty, at about 04:05 hrs, I received credible tip off that some persons were carrying and unloading illegal steam coal at the foot hill of the Sewati Pahar in the Chotobakad village under Jhalda PS. Subsequently, I informed you and as per your gracious order and direction I proceeded to the spot to work out the information. Consequently, we arrived at the spot at about 04:35 hrs and found that a portion of steam coal approx 02 Ton was unloaded at the spot which were as identical as I received prior information. But seeing the Police Party, the persons involved in committing illegal carrying and unloading the steam coal, fled away leaving the said amount of coal at the spot. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. During the endemic enquiry it came to reveal that one Suman Gorain S/O Kalipada Gorain of Vill- Chotobakad, PS-Jhalda, Dist-Purulia along with others was carrying and unloading the steam coal at the spot. It was ascertained that the said person and others loaded the said steam coal from illegal coal mines from Jharkhand state in cahoots with the land owner by illegal mining and tried to sell the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that the said persons in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized the same approx 02 Ton steam coal under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the said steam coal by arranging another goods vehicle to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the Suman Gorain S/O Kalipada Gorain of Vill- Chotobakad, PS-Jhalda, Dist-Purulia and others as they committed offence U/S 379/411/414/120B of the IPC.
