Sir,

In producing herewith one arrested accused person namely Binod Rajak (37) S/O Lt. Ruhidas Rajak of Vill.- Purano Jhalda, PS-Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. 16 (Sixteen) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" on the outer side of the bottles in a plastic bag under proper seizure with label.

I Khirod Baran Sardar of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (30/12/2021) myself along with C/1484-Kajal Kr. Nayak, C/04-Abadhut Kumar, NVF/1036-Parmatha Kuiry, HG/1772-Fatik Ch. Kumar all of Jhalda PS were performing anti crime night mobile duty (This refers to Jhalda PS CC No. 5027 dated 29/12/2021 and GDE No. 1241 dated (29/12/2021). During night mobile duty at about 05:25 hrs I received a credible source information that the above noted accused person was selling country sprit illegally at Purano Jhalda village in his house under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force proceeded to work out the information. At 05:45 hrs we reached at Purano Jhalda village and my source shown the person from a distance who was selling the liquors there. We immediately reached there and surrounded him, and found the huge quantity of country sprit "Dil Khush" bottles were kept there in concealing condition. On searched total 16 (Sixteen) pieces of country sprit "Dil Khush" bottles were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly signed by the accused person & witnesses in between 06:05 hrs to 06:25 hrs in which 01 (one) bottles of "Dil Khush" was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 06:30 hrs after observing all the formalities as per law issuing memo. of arrest as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Binod Rajak (37) S/O Lt. Ruhidas Rajak of Vill.- Purano Jhalda, PS-Jhalda, Dist.- Purulia U/S- 46A (c) of the Bengal Excise Act 1909.
