Sub: First Information Report regarding transportation of 34 Cow for butchering of cattle

Sir

I Santosh Kumar son of Sri Bipin Kumar Singh resident at LH More, Sonatand, Sibandh, Bokaro. Pin -827010.

I would like to inform you that on the judicial order of First Class Judicial Magistrate, Bokaro, Niva Ranjan Lakda, 39 cattle were released on 26/12/2021 at Bokaro. The cattle were brutally loaded in a Vehicle No: JH 0 AP 7832 and transported to West Bengal. The conditions of the cattles were very terrible at vehicle. The vehicle was not suitable for Cattle carriage and was prima facie open breach of The Transport of Animals Rules 1978. The vehicle went to West Bengal and the driving was very uneven.

On 28/12/2021 the vehicle was at Purulia and all the 34 cattles were recovered from Village: Bartand weekly market, At: Bartand, Post: GarhJoypur, P.S.: Joypur, Dist: Purulia with the help of Superintendent of Police, Purulia. The truck driver escaped the place with truck while Bhowrik Yadav son of Sitaram Yadav, Vill: Jamanvidha, P.S.: Parasvidha, Dist: Jahanabad, Awadhesh Prasad Yadav son of Ramjatan Yadav, Vill: Mandir, Post: Parashdigha, Dist: Jahanabad were found with the cattles. As per their information Naresh Yadav son of Ajab Yadav resident at Mugiyachak, P.S.: Hitsava, Dist: Nalanda and Sishupal Kumar son of Somar Prasad, vill: Koushik Nagar, P.S.: Hilsa, Dist: Nalanda were also involved with them.

Therefore I hereby request you kindly Book a FIR u/s 429, 279 of Indian Penal Code and u/s 11(1)(a), (d), (e), (h), (k), (l) of Prevention of Cruelty to Animals Act, 1960 and u/s 48, 49 (a), (b), 52, 54 (1), (2), (3), 56, 96 of Transport of Animal Rules 1978, Article 51 (a)(g) as per Indian Constitution and give punishment to the culprits.
