Sub: Prayer for starting a specific case against one Bhagirath Mahato (24 Y) S/o- Aghnu Mahato of Vill-Banahata PO-Kochahatu PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09AW-2892).

Respected Sir,

With due respect I PLSI Sumana Kar, beg to submit before you that on 30/12/2021 at about 14:15 hrs while myself along with force were performing Special Drive (MV Checking) duty vide Joypur PS CC No-4411 Dated-30/12/2021 at Joypur Parichay Bhavan, College More point on Purulia Ranchi Road. I found one Motor Cycle was coming from Kotshila PS side towards Purulia dangerously with excessive speed. Police personnel, present their in proper Police uniform raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rush and negligently driving the Motor Cycle which may cause accident to the road user any time. After long chase we can able to apprehend him at Joypur College More. On interrogation he made incoherent statement at different time. He disclosed his identity as Bhagirath Mahato S/o- Aghnu Mahato of Vill-Banahata PO-Kochahatu PS-Kotshila, Dist-Purulia. On being asked he failed to produce the driving license and other valid documents of the said Motor Cycle.

Hence he violated the provision of Section 279 IPC & R/W Section 177/182 (1)/183/184 MV Act 1988. So I seized the Motor Cycle having Regd. No- JH09AW-2892 under proper seizure list duly signed by the witnesses and arrested the offending rider namely Bhagirath Mahato S/o- Aghnu Mahato of Vill-Banahata PO-Kochahatu PS-Kotshila, Dist-Purulia aviding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bail-able hence accused rider namely Bhagirath Mahato was released on bail after furnishing proper bail bond.

So I pray before you that a specific case may kindly be registered against the accused namely Bhagirath Mahato S/o- Aghnu Mahato of Vill-Banahata PO-Kochahatu PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09AW-2892) for committing offence U/S-279 IPC & R/W Section 177/182 (1)/183/184 MV Act 1988.
