

Sir,

In producing herewith one arrested accused person namely Hari Shankar Bagti (59 y) S/o-Late Chhatu Bagti of Vill-Khedatard PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 12 (twelve) bottles Illicit country spirit "DIL KUSH" strength 80 up measuring 600 NIL each bottles out of which one bottle taken as sample under proper seizure with label.

I ASI Swapan Mandal of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (30/12/2021) at about 16:25 hrs when myself along with C/-894 Dhananjoy Mandal & C/-1234 Mantulal Mandal were performed special raid duty vide Joypur PS C.C. No-4413/21 Date-30/12/2021, as per my source information I reached at Joypur Tetultol on Purulia-Ranchi road of Tea Stall under Joypur PS and found that the above noted accused person selling country spirit "DIL KUSH" at his shop. On seeing Police persons, he conceal his presence at that shop, but on searching we able to trace out him and also to found that 12 (twelve) bottles of Illicit country spirit "DIL KHUSH" which was kept conceal in a bag in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in Joypur Bazar after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit country sprit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 16:45 hrs to 17:05 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL KUSH as sample out of 12 (twelve) of DIL KHUSH each bottle 600 ML. During further interrogation he confessed his guilt as such I arrested him today 30/12/2021 at 17:10 hrs as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Hari Shankar Bagti (59 y) S/o-Late Late Chhatu Bagti of Vill-Khedatard PS-Joypur, Dist-Purulia, U/S-46A (c) of the Bengal Excise Act 1909.
