In producing herewith 01 (one) arrested accused person namely Daktar Mahato (25 yrs) S/o-Kampu Mahato of Vill-Chapaitard, PS-Joypur, Dist-Purulia along with seized tractor New Mahendra loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (10/12/2021) I along with (1) JC/-1380 Gulam Kadir Ansary (2) NVF/-803 Ankur Mahato both of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-4180/21 Date-10/12/2021. During my mobile duty at about 12:30 hrs I along with force reached at Uparkahan more under Joypur PS and found that a New Mahendra tractor loaded with sand was coming from Uparkahan village side. On seeing the Police party at Uparkahan more, the driver of the said Tractor were trying to fled away. But after a hot chase, we could able to detain the driver of said tractor New Mahendra. On integration he made incoherent statement at different time. He disclosed his identity as Daktar Mahato. I asked the driver Daktar Mahato to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admit that he is dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the Tractor. Hence, I seized the new Mahendra Tractor having Engine. No-RMF2EAN3343 & Chassis No-MBNABAEXKMRF07254 loaded with sand (100 CFT approx) in between 12:45 hrs to 13:05 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Daktar Mahato (25 yrs) S/o-Kampu Mahato of Vill-Chapaitard, PS-Joypur, Dist-Purulia. After observing all formalities & disclosed him about the ground of arrest. I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver of the said Tractor is dealing with sand illegally and transporting with ill motive without any valid document.

So he is liable for offence punishable U/S- 379/411 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against Daktar Mahato (25 yrs) S/o-Kampu Mahato of Vill- Chapaitard, PS-Joypur, Dist-Purulia may kindly be started and arrange for its investigation.
