Sub: Prayer for starting a specific case against one Javed Ansari (23 Y) S/o- Raju Hussion of Vill-Chora, PS-Turuldh, Dist-Seraikella Khrswan State-Jharkhand (Motor Cycle Rider having Regd. No- JH05U-8853).

Respected Sir,

With due respect I SI Dibakar Kuiri, beg to submit before you that on 10/12/2021 at about 10:25 hrs while myself along with force were performing Special Drive (MV Checking) duty vide Joypur PS CC No-4182/11 Dated-10/12/2021 at Ranibandh Railgate on Purulia Ranchi Road. I found one Motor Cycle was coming from Rakhbar side towards Joypur Bazar with excessive speed and dangerously. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Railway level crossing. On interrogation he made incoherent statement at different time. He disclosed his identity as Javed Ansari (23 Y) S/o- Raju Hussion of Vill-Chora, PS-Turuldh, Dist-Seraikella Khrswan State-Jharkhand. On being asked he failed to produce the driving license and other valid documents of Motor Cycle.

Hence he violated the provision of Section 279 IPC & R/W Section 177/182 (1)/183/184 MV Act 1988. So I seized the Motor Cycle having Regd. No- JH05U-8853 under proper seizure list duly signed by the witnesses and arrested the offending rider namely Javed Ansari (23 Y) S/o- Raju Hussion of Vill-Chora, PS-Turuldh, Dist-Seraikella Khrswan State-Jharkhand after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Javed Ansari was released on bail.

So I pray specific case may kindly be registered against the accused namely Javed Ansari (23 Y) S/o- Raju Hussion of Vill-Chora, PS-Turuldh, Dist-Seraikella Khrswan State-Jharkhand (Motor Cycle Rider having Regd. No- JH05U-8853) for committing offence U/S-279 IPC & R/W Section 177/182 (1)/183/184 MV Act 1988.
