With due respect I SI Dibakar Kuiri, beg to submit before you that on 10/12/2021 at about 10:25 hrs while myself along with force were performing Special Drive (MV Checking) duty vide Joypur PS CC No-4182/11 Dated-10/12/2021 at Ranibandh Railgate on Purulia Ranchi Road. I found one Motor Cycle was coming from Rakhbar side towards Joypur Bazar with excessive speed and dangerously. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Railway level crossing. On interrogation he made incoherent statement at different time.
