

Prayer for starting a specific case against one Sukumar Kumar (27 Y) S/o- Late Nayan Kumar of Vill-Beradih PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No-Sub: JH09AM/4349).

Respected Sir,

With due respect I SI Nagendra Nath Das, beg to submit before you that on 10/12/2021 at about 15:55 hrs while myself along with force were performing Special Drive (MV Checking) duty vide Joypur PS CC No-4183 Dated-10/12/2021 at Kathaltard Naka point on Purulia Bokaro Road. I found one Motor Cycle was coming from Bokaro side towards Purulia with excessive speed and dangerously. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Kathaltard Naka point. On interrogation he made incoherent statement at different time. He disclosed his identity as Sukumar Kumar (27 Y) S/o- Late Nayan Kumar of Vill-Beradih PS-Kotshila, Dist-Purulia. On being asked he failed to produce the driving license and other valid documents of Motor Cycle.

Hence he violated the provision of Section 279 IPC & R/W Section 177/182 (1)/183/184 MV Act 1988. So I seized the Motor Cycle having Regd. No- JH09AM/4349 under proper seizure list duly singed by the witnesses and arrested the offending rider namely Sukumar Kumar (27 Y) S/o- Late Nayan Kumar of Vill-Beradih PS-Kotshila, Dist-Purulia after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Sukumar Kumar was released on bail.

So I pray specific case may kindly be registered against the accused namely Sukumar Kumar (27 Y) S/o- Late Nayan Kumar of Vill-Beradih PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No- JH09AM/4349) for committing offence U/S-279 IPC & R/W Section 177/182 (1)/183/184 MV Act 1988.
