> Sub: Prayer for lodging FIR against accd Bishnu Kuiri@ Bablu(26), s/o- Jagadish Kuiri of Vill-Baishakitard PS-Joypur Dist-Purulia U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused (1) Bishnu Kuiri@ Bablu(26), s/o- Jagadish Kuiri of Vill-Baishakitard PS-Joypur Dist-Purulia along with seizure – list and seized items as described below, I beg to state that on 10.12.2021 at about 17.15 hrs dunging my evening mobile duty (vide CC No-1961/21), received a source information to the effect that the illicit liquor (Mohulla) has been kept at Chokudi morh in to the shop of above noted accused illegally with an object to sale. I convey the matter to the OC Baglata IC and as per order of OC Baglata IC. I along with force left for Chokudih village to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the shop of Bishnu Kuiri at about 17.45 hours. Seeing police van some unknown persons in front of the shop of Bishnu Kuiri fled away. However, I could detain Bishnu Kuiri and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the illicit liquor (locally known as Mohulla) for selling and he was the owner of the said shope. However, I along with said accused started a search inside the shope of Bishnu Kuiri and found the following item in the said house:

## 1) One white colour plastic Jariken containing approx 05 lit illicit liquor (locally known as Mohulla)

I interrogated him about the purpose of the stocking and possessing illicit liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List in between 18:05 hrs and 18.15 hrs & took up its 500ml (approx) into a plastic bottle as sample, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the illicit liquor without any valid papers in his shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 18.20 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Bishnu Kuiri@ Bablu(26), s/o- Jagadish Kuiri of Vill-Baishakitard PS-Joypur Dist-Purulia.
