Sub: To lodge FIR against owner and driver of Power Track 439 (Blue Colour) Tractor having Registration No WB 68AC 2006, along with trolley (without number plate) loaded with sand approx 40-45 Cft.

Sir,

In producing herewith, one Arjun Bauri (20 Years) S/O Bijoy Bauri of village – Tilajuri, PS – Chhatna, Dist – Bankura along with (i) 01 (One) tractor i.e. Power Track 439 (Blue Colour) Tractor having Registration No WB 68AC 2006, along with trolley (without number plate) loaded with sand approx 40-45 Cft (ii) 02 piece old Iron made "Belcha" having iron butt and (iii) 02 piece iron made "Dhama" before you.

The nub of the fact in a nutshell is that today on 21.12.21 at 08.25 hrs. I ASI Shyamal Ch Mandal of Kashipur PS along with (i) C/1208 Suresh Hembram and (ii) C/726 Dipankar Mahato both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 902 Dtd – 21.12.2021 and C.C No. 3205/21 Dtd. 21.12.2021. During my mobile duty, I received a tip off at 12.45 hrs. that some persons were loading one tractor with sand from the river bed of Darkeswar River near Chapri village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractor and detained the said tractor and somehow we managed to apprehend one person. On interrogation he disclosed his name noted in the supra, who is the driver of said vehicle. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So I, seized (i) 01 (One) tractor i.e. Power Track 439 (Blue Colour) Tractor having Registration No WB 68AC 2006, along with trolley (without number plate) loaded with sand approx 40-45 Cft (ii) 02 piece old Iron made "Belcha" having iron butt and (iii) 02 piece iron made "Dhama" in between 13.15 hrs to 13.25 hrs under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver Arjun Bauri (20 Years) S/O Bijoy Bauri of village – Tilajuri, PS – Chhatna, Dist – Bankura at 13.35 hrs after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said tractor to Kashipur P.S. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and arrested driver of above noted tractor along with the trolley for investigation.
