Sir,

In producing herewith arrested accused person Sk Sharif (22 Years) S/O Sk Ismail @ Sk Fekna of Telkalpara (Ward No - 16), Purulia, PS - Purulia (T), Dist - Purulia along with seized article i.e. one Red Colour Pulsar Motor Cycle having Registration No WB 56E 1201, Engine No DJGBSD69575 & Chassis No - MD2DHDJZZSCD54177.

I beg to report that today myself along with C/628 Giridhari Bauri and NVF/693 Jayanta Singh Sardar both of Kashipur PS were performing day mobile duty near Napara Petrol Pump under Kashipur PS area vide Kashipur PS C.C No - 3293/21 dtd. 29.12.2021 and Kashipur PS GDE No - 1259. At about 12.45 hrs, I found one Red Colour Pulsar Motor Cycle coming from Gamarkuri side towards Kashipur rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss / serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he also failed to produce any driving license.

So, I seized the said Red Colour Pulsar Motor Cycle having Registration No WB 56E 1201, Engine No DJGBSD69575 & Chassis No - MD2DHDJZZSCD54177 in between 12.55 hrs to 13.05 hrs. and arrested him at about 13.15 hrs. as he had committed an offence punishable under sec 279 IPC and 181/184 MV Act 1988 in presence of police party and informed his family members accordingly.

Hence, I pray that a specific case U/S 279 IPC and 181/184 MV Act 1988 may kindly be initiated against accused Sk Sharif (22 Years) S/O Sk Ismail @ Sk Fekna of Telkalpara (Ward No - 16), Purulia, PS - Purulia (T), Dist - Purulia.
