In producing herewith arrested accused person Dilip Bauri (27 Years) S/O Subhas Bauri of Aguibad (Dhabari), PS - Adra, Dist - Purulia along with seized articles (1) One Red and Black Colour Honda Livo Motor Cycle, having registration No WB 82D/4173 Engine No - JC71-G-0059755 & Chassis No - ME4JC719HKG031764.

I beg to report that today myself along with C/1256 Anadi Dhibar and NVF/041 Paltulal Mahato both of Kashipur PS were performing day mobile duty at Kolloli Hospital More under Kashipur PS area vide Kashipur PS C.C No - 3166/21 dtd. 17.12.2021 and Kashipur PS GDE No - 741. At about 13.20 hrs, I found One Red and Black Colour Honda Livo Motor Cycle coming from Talajuri side towards Kashipur rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he also failed to produce any driving license.

So, I seized the motor cycle having registration No WB 82D/4173 Engine No - JC71-G-0059755 & Chassis No - ME4JC719HKG031764 (Red and Black Colour Honda Livo) in between 13.25 hrs to 13.40 hrs. and arrested him at about 13.45 hrs. as he had committed an offence punishable under sec 279 IPC and 181/184 MV Act 1988 in presence of police party and informed his family members accordingly.

Hence I pray that a specific case U/S 279 IPC and 181/184 MV Act 1988 may kindly be initiated against accused Dilip Bauri (27 Years) S/O Subhas Bauri of Aguibad (Dhabari), PS - Adra, Dist - Purulia.


