Sir,

With reference to the above, this is to inform that some unknown persons have been found to be extracting white stones from a spot at Ranidih village near Parbaid under the jurisdiction of B.L. & L.R.O. Puncha, the land schedule of which is mentioned below. The miscreants fled away from the spot during joint raid along with the SDL&LRO-Sadar, and other officials from the Land & Land Reforms Department at about 11:00 am on 03.12.2021.
