Sir,

In producing herewith arrested accused person namely Kanchan Bouri (20 Yrs) S/o-Lt. Nilkamal Bouri of Gopibabu Lane, Garikhana (Gowala Bandh), Ward No- 20, PS-Purulia (T), Dist- Purulia along with one seized red colour Appachi-160 Motor Cycle bearing Registration No-WB 56N-8613.

I beg to report that today myself along with C/631 Tulshi Das Satpathi and HG /1933 Lakhindar Mura both of Kenda PS were performing day mobile duty at Panipathar Morh under Kenda PS area vide Kenda PS C.C No-1424/21 dtd. 06.12.2021 and Kenda PS GDE No-179 dtd- 06.12.21 At about 13:05 hrs, I found one motor Cycle bearing Registration No-WB 56N-8613 coming from Darodih Morh side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Kanchan Bouri (20 Yrs) S/o- Lt. Nilkamal Bouri of Gopibabu Lane, Garikhana (Gowala Bandh), Ward No- 20, PS-Purulia (T), Dist- Purulia.
