Respected Sir,

I, SI Subhendu Sekhar Bera of Kenda PS, Dist- Purulia in producing here with one arrested accused person namely Mangal Chandra Mahato (41Yrs), S/o- Lt. Dukhabhanjan Mahato of Vill- Mohandih, P.S - Kenda, Dist- Purulia with seized articles i.e. 1) One white colour jarican containing Approx 09 Ltrs. ID Liquor 2) 10 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles in Sl No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (30-12-2021) during special raid duty acting on a secret source information myself along with (1) C/1177 Samir Das (2) C/ 2519 Arun Duley all are of Kenda PS conducted raid in the house of accused person namely Mangal Chandra Mahato at about 17.25 hrs and found that he was keeping and selling of ID liquor to the others at his house at Mohandih village. Seeing the Police party, all customers fled way but we managed to apprehend the above noted accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing Approx 09 Ltrs. ID liquor 2) 10 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles in Sl. No-01 & kept in a bottle under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities of arrest. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about the ground of arrest and place of detention.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Mangal Chandra Mahato (41 Yrs), S/o – Lt. Dukhabhanjan Mahato of Vill- Mohandih, P.S – Kenda, Dist- Purulia as per proper section of law.
