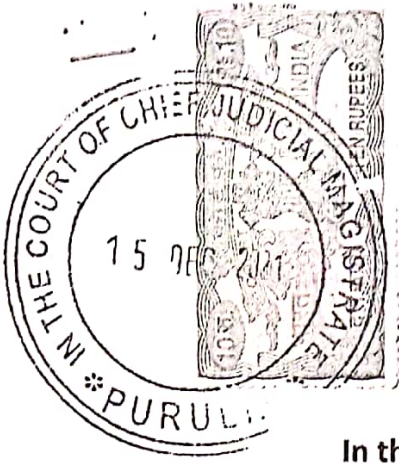

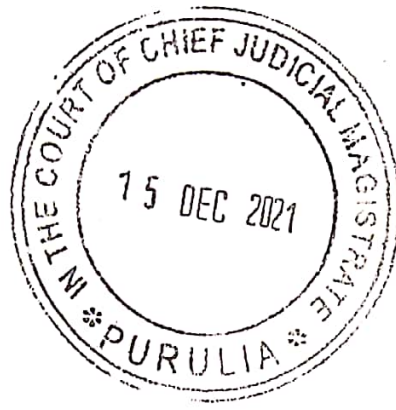

The above-named complainant/petitioner begs to state as follows:

1. That your petitioner/complainant is now residing at village-Kochahatu, P.S-Kotshila, Dist- Purulia, West Bengal, which is her paternal home. Witness no.2, witness no 3 and witness no 4 are the relatives of the petitioner/ complainant.
2. That on 12<sup>th</sup> day of Boishak 1426 B.S i.e on 26/04/2019 the complainant was married to Deepak Kumar S/O Shaktipada Kumar, resident of village- Bararola, P.S- Kotshila, Dist- Purulia, W.B. as per Hindu rights and customs. The said marriage was performed at village-Kochahatu, P.S- Kotshila, Dist- Purulia, W.B. At the time of marriage, the father of the complainant Mahashwar Kumar had paid Rs 1,26,000/- cash and jewellery, almirah, bed and other household articles worth Rs 1,50,000/- as per dowry demand of the father-in-law of the complainant.
3. That after marriage the complainant went to her matrimonial home and stayed well for few days but after four to five months of marriage the husband of the complainant, father-in-law, mother-in-law and other accused mentioned above started putting pressure upon the complainant and demanded further dowry of rupees one lakh and told her to bring it from her father's house.
4. That the complainant informed to her father regarding the further demand of rupees one lakh made by her husband and other in-laws, but the father of the complained could not fulfil such demand of money then on 21/12/2019 all the in-law family members including her husband started inflicting torture upon the complainant both mentally and physically and all of them brutally assaulted the complainant with lathi over her head with an intention to finish her off as a result she suffered grievous injury on her head, she was admitted to Kotshila primary health centre and she was given stiches on her head, CT scan of brain was conducted. Thereafter the father of the complainant went to Kotshila P.S to lodge complain but with the intervention of the local panchayat members the dispute was settled between the complainant and her in-laws, after that the complainant again started to reside at her matrimonial home with a hope that the dispute is settled and she can lead a health matrimonial life.
5. That on 25<sup>th</sup> day of Posh 1428, i.e 10<sup>th</sup> January 2021 the complainant gave birth to a female child (Bishakha Kumar) out of their wedlock. The

husband and other-in-laws were expecting a male child but as it was a female child the complainant soon started facing humiliation at her matrimonial home, she was subjected to inhuman anguish, denied proper nutrition, she was forced to do all domestic hard work, she was subjected to mental and physical torture, faced abusive languages and very often bitten up by her husband and the in-laws used to tell the complainant “*golai dori deye moray jaa, chelay jonmo detae parli nai.*”

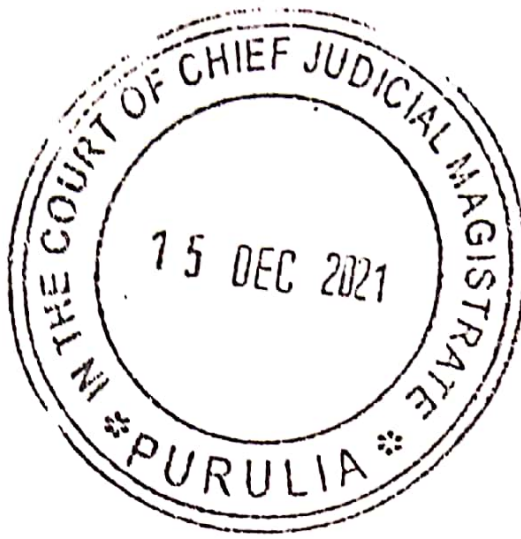
6. That finally on 21<sup>st</sup> day of Ashwin 1428, i.e on 08/10/2021, at about 12.00 to 12.30 pm at village-Bararola, when the complainant was breast feeding her infant daughter then the husband Deepak Kumar, Shaktipada Kumar (Father-in-law), Rukini Kumar(Mother-in-law), Sudhir Kumar (Elder-Brother-in-law), Kartick Kumar(Elder Brother-in-law) all of them outlined a criminal conspiracy and with common intention to murder the complainant and her daughter, poured kerosine oil over the complainant and her 10 month old daughter and ignited them with fire. The complainant when felt the heat reacted promptly and managed to remove her saree which got burned and any how succeeded to free herself from the claws of her in-laws and went to her father’s house and narrated the conspiracy hatched by her husband along with other in-laws to murder her and her infant child.

7. That thereafter the complainant along with her father went to Kotshila P.S to lodged a specific complain against the above accused but police refused to lodged their complain.

8. That finding no other alternatives your petitioner has knocked the door of Superintendent of Police, Purulia on 06/12/2021 but nothing has been done from his end.

9. That your petitioner is a helpless woman having full faith in the justice delivery system of the country and for all these it is desirable and prayed that this case should be converted to a police case.
