Sub: Complain to start a specific case.

Sir,

In producing herewith one buffalo cart fitted with two buffaloes loaded with raw coal approx 01 MT, I, ASI Rajkumar Goswami, do hereby lodge a complaint to the effect that on 30.12.2021 myself along with C/1319 Soumen Koley and C/399 Kartik Chandra Mura all are of Neturia PS were engaged in day mobile duty vide Neturia PS GDE No- 1304 Dt. 30.12.2021 & CC No- 3500 Dt. 30.12.2021. In course of mobile duty at about 16.25 hrs when we reached at Jhanka More, at that time received credible source information that one buffalo cart loaded with coal coming from Murulia side after procuring the same coal illegally with a view to dispose off to Neturia side through Murulia – MSPL road in clandestine manner. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force proceeded towards MSPL factory side on way when reached near Moutha at about 16:45 hrs found that above noted buffalo cart coming from Murulia side. Suddenly the bullock cart stopped about 75/80 meter away from us and one person got down from the buffalo cart and started running towards jungle side. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding area to find out the person but failed to trace out him. On search we found that buffalo cart is loaded with raw coal of 01 MT (approx).

So, there is reason to believe that the buffalo cart driver and owner of the said buffalo cart have collected the said coal either by theft or any illegal means to dispose off the same for wrongful gain. So, I have seized the said buffalo cart (Two buffaloes) loaded with raw coal approx 01 MT under proper seizure list. There was no such public witness available at that time of seizure thereafter I arrange to & could able to shift the seized buffalo cart (Two buffaloes) loaded with raw coal approx 01 MT at Neturia PS compound.

I, therefore pray before you to lodge a specific case against owner and driver of the buffalo cart under proper section of law.
