Dear Sir,

I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that **Sri Sanjay Mondal(Present User), S/O- Sri Subodh Mondal**, a permanent resident of **Vill & Post- Guniara ,P.S -Neturia, Dist- Purulia** has committed theft of Electricity u/s 135 (1)(b)of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On **09.12.2021** at **03:25PM** I, Dhritiman Sardar S/O- Rupal Sardar, aged about 24 years, AE & SM Saltore CCC, along with Md.Jiaur Rahaman Mondal (DE, S&LP) Sankar Chandra Mahato (ACM) both attached to the Purulia Region Office and Sri Sibdas Ball, J.E. (Gr-I), Saltore CCC had been to the village- Guniara for routine inspection purpose. One notice was served upon Sanjay Mondal prior to inspection duly received by him.

During inspection it was found that **Sri Sanjay Mondal S/O- Sri Subodh Mondal** was consuming electricity dishonestly in his Domestic premises **unauthorisedly by the way of bypassing the energy meter against consumer ID:242029621 of WBSEDCL without registering actual consumption by inserting wire from incomming contact of the meter** causing considerable loss of revenue of WBSEDCL. Total load found **0.392 KW**. The total modus operandi was photographed and attached with this Complaint.

As theft of electricity was detected during inspection the illegal bypassing arrangement along with energy meter bearing SL No:L2063489, Make: Landis & Gyr Ltd was disconnected & seized from the premises as a token of the offence under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Sanjay Mondal refused to acknowledge the same by putting his signature in the Seizure List, Inspection Report. After completion of inspection, the inspection team left the aforesaid premises at about **03:50PM on 09.12.2021**.

Thus the accused **Sri Sanjay Mondal, S/O- Sri Subodh Mondal, Vill & Post- Guniara, P.S -Neturia, Dist- Purulia** have committed an offence **u/s 135(1)(b)** of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complaint treating it as FIR.
