Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Sudhir Bouri (45) S/O- Lt. Helu Bouri of Vill-Tarabari, PO-Tarabari, PS-Santuri, Dist-Purulia, A/P- Vill- Madandih, near Shakambhari Ispat & Power Ltd. (Jyoti Hotel), PS-Neturia, Dist-Purulia with seizure of 21 pcs Sealed bottles of Bumper Country spirit containing 300 ml each (MRP Rs. 28/Each) which were seized under proper seizure list.

I beg to submit that today (10.12.21) while I, ASI Rajkumar Goswami, along with force were performing special mobile duty vide Neturia PS GDE No-438 Dt. 10.12.21 and acting on source information after consulting you at about 16:35 hrs reached at Madandih village near Shakambhari Ispat & Power Ltd. and held raid in the Hotel styled as "Jyoti Hotel" of Sudhir Bouri (45) S/O- Lt. Helu Bouri of Vill-Tarabari, PO-Tarabari, PS-Santuri, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Sudhir Bouri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 21 pcs Sealed bottles of Bumper Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Sudhir Bouri (45) S/O- Lt. Helu Bouri of Vill-Tarabari, PO-Tarabari, PS-Santuri, Dist-Purulia, A/P- Vill- Madandih, near Shakambhari Ispat & Power Ltd. (Jyoti Hotel), PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1361 Munshi Kamal Hassan (2) C/564 Prasad Majhi and (3) C/399 Kartick Ch. Mura all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Sudhir Bouri (45) S/O- Lt. Helu Bouri of Vill-Tarabari, PO-Tarabari, PS-Santuri, Dist-Purulia, A/P- Vill- Madandih, near Shakambhari Ispat & Power Ltd. (Jyoti Hotel), PS-Neturia, Dist-Purulia under proper section of law.
