Sub:- Complain for starting a specific case .

Sir,

In producing herewith one arrested accused namely Abhijit Roy (24Yrs) S/O- Manshu Roy of Vill- Konsui P.O- Mihijam, PS- Mihijam Dist- Jamtara, Jharkhand, A/P- Baghardanga, P.O- Saltore, PS- Neturia, Dist- Purulia (Driver of tractor No- WB 55A/1628) and seized Red Color Shaktiman -35 tractor with trolley having registration number WB 55A/1628 loaded with sand approx 100 Cft. under proper seizure list. I beg to submit that I, ASI Rajkumar Goswami along with C/939 Laltu Paul and C/1319 Soumen Kole all are of Neturia PS were performing night mobile duty vide Neturia PS CC No- 3348/21 Dt. 15.12.21 and at about 00:30 hrs received a credible source information that one Tractor was coming from Baghardanga Damodar river Ghat side and proceeding towards Jhanka side loaded with sand illegally. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Jhanka village side. At about 00:45 hrs we reached near Jhanka More and found that one tractor is coming from Ranipur side but the vehicle suddenly stopped 30/50 meter away from us and one person from said vehicle seems to be the drivers of the vehicle got down from the vehicle and started running. We chased to apprehend the person and after hot chase we managed to apprehend the above noted person. Then we searched the vehicle and found that the vehicle (Tractor) having registration No- WB 55A/1628, loaded with sand approx 100 cft. On being asked the detained driver, failed to produce any relevant documents in respect of loaded sand as well as failed to produced vehicle related documents and on interrogation he stated that one Bam Kumbhakar S/O- Dhiren Kumbhakar of Baghardanga, PS- Neturia, Dist- Purulia is the registered owner of the above noted vehicle.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Jhanka village side knowing it to be stolen, as per their regular practice.

Accordingly I seized the Tractor bearing No WB 55A/1628, along with trolley loaded with sand approx 100 C.F T. under proper seizure list duly signed by witnesses and arrested the above noted accused driver after maintaining all formalities of Hon'ble Apex Court of India. So, the driver of said tractor and registered owner of the said tractor have committed offence U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against Abhijit Roy (24Yrs) S/O- Manshu Roy of Vill- Konsui P.O- Mihijam, PS- Mihijam Dist- Jamtara, Jharkhand, A/P- Baghardanga, P.O- Saltore, PS- Neturia, Dist- Purulia (Driver of tractor No- WB 55A/1628) and Bam Kumbhakar S/O- Dhiren Kumbhakar of Baghardanga, PS- Neturia, Dist- Purulia (Registered owner of tractor No-WB 55A/1628) U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
