In producing herewith the two (02) arrested accused persons namely 1) Sagar Osta (24 Yrs) s/o Kismat Osta of Vill.- Bamunbaid, PS- Para, Dist.- Purulia and 2) Alauddin Ansary @ Ali (28 Yrs) S/o Samsuddin Ansary of Vill- Ranipur Belgara, PS- Para, Dist- Purulia with seized articles as per seizure list.

I, ASI Rajib Tewari of Para PS beg to report that on the night of 30.11.2021 myself along with force viz, C/1407 Susanta Goswami, NVF/822 Mangal Mahato and NVF/869 Swarup Addy were performing Night patrolling duty at Jhapra side area vide Para PS GDE No- 1182 and CC No-3088/21 dated 30.11.2021 with Govt. vehicle. At 22.15 hrs received a credible source information that 10/12 persons being armed with deadly weapons assembled in an open place near Jhapra Chati Arjun Bagan under Para PS with a view to commit dacoity on vehicular traffic which were playing on SH-05 (Purulia- Barakar) road. The information was communicated to O/C Para P.S and as per his direction myself along with another officer ASI Dipankar Mahanti along with his accompanied force namely C/23 Chandi Mukherjee and NVF/487 Kirtan Sing Sardar assembled at Jhapra Chati and left for the possible place of occurrence. We reached at the spot just ½ km before the place of occurrence at 22:35 hrs. Keeping the vehicle in a safe distance, we started on foot and slowly arrived near the spot and heard some whispering of some persons. We the Police party without wasting a single moment tried to encircle them from behind. With the help of the focus of the torch light we found that 10/12 persons being armed with deadly weapons like rod, shabal, lathi were assembled in an open place near Jhapra Chati. Seeing the Police party all of them started to escape but after a hot chase the above 02 accd. persons could be apprehended.

On primary interrogation the apprehended accused persons stated their names and addresses as noted above were assembled there for committing dacoity over vehicular traffic playing on SH-05 (Purulia- Barakar) road was quite dark and tranquil. Before entering into the search of the person of the accd persons, tried to find out some local independent witnesses but as

the place is an isolated one none could be available.

During search of the said accd persons 1) One iron made "BHOJALI" measuring 10 inch approx and one plastic Torch was recovered from the possession of accused Sagar Osta S/o Kismat Osta and 2) One iron rod length 5 feet approx and one plastic Torch light was recovered from the possession of accused Alauddin Ansary @ Ali (28 Yrs) S/o Samsuddin Ansary. So there is sufficient reasonable ground to believe that they were assembled there at that odd hours with deadly weapons with a view to commit dacoity on vehicular traffic. So, I arrested them, informing them of the ground of their arrest and seized the above articles under proper seizure list duly signed by witnesses and accd persons observing all formalities and procedures of law. The seizure was made between 22.55 hrs to 23.25 hrs. on 30.11.2021.

Therefore I pray that a specific case may kindly be started against the above noted accd. persons and arrange for its investigation.
