Sir,

In producing herewith arrested accused person namely Bulet @ Brajakishor Gope S/o Trilochan Gope of Village- Dheria, PS- Para, Dist- Purulia along with seized one Hero Honda Splendor Motor cycle bearing Reg. No- JH09E/4489.


I beg to report that today myself along with C/1281 Sachin Singh Bhuinya, and NVF/030 Bhismadeb Mahato both of Anara OP under Para PS were performing day mobile duty at Mahadebpur more under Para PS area vide Anara OP under Para PS Misc C.C No- 2026 dtd 21.12.2021 and Anara OP under Para PS GDE No- 265 dtd. 21.12.2021. At about 13.45 hrs, I found one Hero Honda Splendor Motor cycle bearing Reg. No- JH09E/4489 coming from Anara side rashly and negligently. We tried to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he failed to produce his driving license and valid paper in support of said vehicle.

So, I arrested him as he violated sec 279 IPC and 181/184 M.V Act. at 13.55 hrs. I also seized the motor cycle Hero Honda Splendor with a view to prosecute him U/S 279 IPC and 181/184 M.V Act. in presence of witnesses. The whole process of seizure was completed in between 14.05 hrs to 14.15 hrs. His family member was also informed about the ground of arrest.

Afterwards he was released on bail after issuing Bail bond & PR bond.

Hence I pray that a specific case U/S 279 IPC and 181/184 M.V Act. may kindly be initiated against Bulet @ Brajakishor Gope S/o Trilochan Gope of Village- Dheria, PS- Para, Dist- Purulia.
