Sir,

In producing herewith arrested accused person namely Laldeb Mudi (28yrs) S/o Krishnapada Mudi of Village- Tentulhiti, PS- Para, Dist- Purulia along with seized one Hero Honda Super Splendor Motor cycle bearing Reg. No- WB-56F/0416

I beg to report that today myself along with C/1184 Subhendu Maity, C/1511 Sudarson Baur and NVF/487 Kirtan Sing Sardar all of Para PS were performing evening mobile duty at Rukni more under Para PS area vide Para PS Misc C.C No- 3189 dtd 10.12.2021 and Para PS GDE No- 399 dtd. 10.12.2021. At about 1650 hrs, I found one Hero Honda Super Splendor Motor cycle bearing Reg. No- WB-56F/0416 coming from Raghunathpur side rashly and negligently. We tried to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he failed to produce his driving license and valid paper in support of said vehicle.

So, I arrested him as he violated sec 279 IPC and 181/184 M.V Act. at 16.55 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 181/184 M.V Act. in presence of witnesses. The whole process of seizure was completed in between 17.05 hrs to 17.15 hrs. His family member was also informed about the ground of arrest.

Afterwards he was released on bail after issuing Bail bond & PR bond.

Hence I pray that a specific case U/S 279 IPC and 181/184 M.V Act. may kindly be initiated against Laldeb Mudi (28yrs) S/o Krishnapada Mudi of Village- Tentulhiti, PS- Para, Dist- Purulia.
