I beg to submit that today (10.12.2021) during my Evening Mobile duty, I received credible source information that one Buju Gorain (56yrs) S/o Lt- Nibaran Gorain of Village- Jorberia, PS- Para, Dist- Purulia has stored huge quantity of Country Spirit for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 15.25 hrs to 15.35 hrs I held raid at Jorberia Palash Bagan under Para PS of accused Buju Gorain (56yrs) S/o Lt- Nibaran Gorain of Village- Jorberia, PS- Para, Dist- Purulia and found that the above noted person was selling Country Spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying Country Spirit fled away. I asked the above noted person to produce license for selling such Country Spirit, but he did not have any authorization or license in support of said Country Spirit.
