house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ① 0.5 H.P Water Pump [Kinkosken] ② Two cone flexible wire
100 meters approx
- ③ 01 (one) no. three pin box
