installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

① 2 nos bulb (100 Watt each)

Out of which I seized the following.

- ① 2 Core flexible cable (1.0 meter approx)
- ② Switch board
