The complainant begs to state as follows : -

- 1. That the complainant is the legally married wife of the accused no. 1 and their marriage has been solemnised on 19.02.2001 at Village Naranpur, P.S. Joypur, District Purulia. The said marriage was performed according to Islam rights and customs and according to the ceremonies prevalent in their community and the said marriage is still subsisting.
- 2. That at the time of marriage as per demand of the accused persons the father of the complainant had to give a cash of %. 1,00,000/- along with other valuable articles and ornaments the value of the same are %. 80,000/- but the accused persons were not satisfied with either cash or articles so given to the accused persons.







3. That after marriage the complainant was taken to her matrimonial home by the accused persons and started to reside there as husband and wife with the accused no.1 along with other accused persons in the same mess and house.

4. That out of their marriage / wedlook no child was born and accordingly all the accused persons started torture both physically and meantally upon the complainant and they father demanded of Rs. 50,000/- and abused the complainant as witch and further told her that they will not allaru the complainant in their house it the father of the complainant does not fulfil the demand of the accused persons.

That the complainant bearing all such torture stayed at her matrimonial house for a good days .

5. That on 21.04.2021 corresponding to 7th day of Baisakh all the accused persons with comon object and intention assaulted the complainant and after snatching her all ornements drove her out from their house even they are tried to finish her but at the intervention of the villagers her life was saved and she reached her father house at village Naranpur later the complainant came to know that her husband i.e. accused no.1 have got marriage with another girl.







- 6. That the aforesaid incident of torture and attempt to murder was informed to the Officer -in-charge of purulis (M), Police Station but no action has yet been taken from their ends.
- 7. That the compainant informed the matter to the S.P. Purulis on 28.10.2021 but till today no case has been started hence this petition.
- 8. The complainant is a helpless lady has no capesity to continue the case ather own cost.

It is therefore most respectfully prayed that your bonour may be graciously pleased to pass and order to send the petition of complain to the Officer in charge of Purulia (M) Police Station treating the same as F.I.R. u/s 156(3) of cr.O.code.
