I beg to submit that today (30.12.2021) while I was detailed to perform evening and night duty in PS area along with force i) C/1410/ Surajit Patra & (ii) C/2734 Susanta Panda both are Purulia (M) PS & Purulia (M) PS C.C. No 4012/2021 Dt. 30.12.2021 and GDE No 1339 Dtd. 30.12.2021. During my mobile duty, I received a secret tip off that an illegal possession of huge amount of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that a Tea shop opposite side of FCI Chharrah Godown and after arriving at the spot and as per instruction conducted raid in the shop of Rajkumar Das under this PS at 18:15 hrs. During the raid 2/3 persons fled away near the Tea shop and detained one person. On asking the identity he disclosed his name address as noted supra.
