Sub: **Complaint against** Rajkumar Das (37) S/O Lt. Kinkar Das Das of Vill- Khannadih. PS- Purulia (M), Dist- Purulia to start a cog case u/s 46 A (c) of Bengal Excise Act. 1909.

Sir,

In producing herewith one arrested accd. person namely Rajkumar Das (37) S/O Lt. Kinkar Das Das of Vill- Khannadih, PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (30.12.2021) while I was detailed to perform evening and night duty in PS area along with force i) C/1410/ Surajit Patra & (ii) C/2734 Susanta Panda both are Purulia (M) PS & Purulia (M) PS C.C. No 4012/2021 Dt. 30.12.2021 and GDE No 1339 Dtd. 30.12.2021. During my mobile duty, I received a secret tip off that an illegal possession of huge amount of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that a Tea shop opposite side of FCI Chharrah Godown and after arriving at the spot and as per instruction conducted raid in the shop of Rajkumar Das under this PS at 18:15 hrs. During the raid 2/3 persons fled away near the Tea shop and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit for selling illegally from his shop so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit at his shop. Subsequently, I seized 20 (twenty) sealed bottles liquors of country sprite each containing 600 ml., MRP 50/- per bottles which is styles as "Dil Khush" and kept 01 sealed bottles as sample from 20 (twenty) bottles under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Rajkumar Das (37) S/O Lt. Kinkar Das Das of Vill- Khannadih, PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his shop. Under the fact and circumstance kindly take necessary lawful action against Rajkumar Das (37) S/O Lt. Kinkar Das Das of Vill- Khannadih, PS- Purulia (M), Dist- Purulia.
