Sir,

In producing herewith one arrested accd. person namely Kshirode Kr. Mahato (41) S/O Lt. Arjun Mahato of Vill- Gopalpur, , PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that on 09.12.2021 while I was detailed to perform evening & Night Mobile duty in PS area along with force i) C/683 Mansaram Rajak (ii) C/624 Pradip Chakraborty & (iii) C/06 Debdas Mukherjee of Purulia (M) PS & Purulia (M) PS C.C. No 3803/2021 Dt. 09.12.2021 and GDE No 346 Dtd. 09.12.2021. Today (10.12.2021) during my mobile duty, I received a secret tip off that an illegal possession of huge amount of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that is Gopalpur village more and after arriving at the spot and as per instruction conducted raid in the Pan Stall of Kshirode Kr. Mahato under this PS at 07:45 hrs. During the raid 2/3 persons fled away near the Pan Stall and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit for selling illegally from his Pan Stall so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit at his Pan Stall. Subsequently, I seized (i) 18 (eighteen) **sealed bottles liquors of country sprite each containing 600 ml., MRP 60/- per bottles which is styles as "Dil Khush" and kept 01 sealed bottles as sample from 18 (eighteen) bottles** under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Kshirode Kr. Mahato (41) S/O Lt. Arjun Mahato of Vill- Gopalpur, , PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his Pan Stall. Under the fact and circumstance kindly take necessary lawful action against Kshirode Kr. Mahato (41) S/O Lt. Arjun Mahato of Vill- Gopalpur, , PS- Purulia (M), Dist- Purulia.
