

Most respectfully begs to state:-

1...That your complainant is a legally married wife of the accused no.1 and marriage between the complainant and accused no.1 was solemnized on 19.04.2016 corresponding

to the 6<sup>th</sup> day of Baisakh 1423 as per Bengal Calendar, as per Hindu ritual and customs prevails in their society at "BIKASH BHABAN" Ranchi Road, P.O. Purulia, P.S. Purulia (Town), District- Purulia, in presence of both the family members and near relatives and within the jurisdiction of this Ld. Court.

2...That the marriage between the parties was result of a negotiation and it was an arranged marriage. At the time of the negotiation of marriage all the accused person introduced accused No.1 (Bridegroom) as a Manager "HDFC BANK" and working in New Delhi by suppressing the facts that actually the accused person was an employee of a BPO and working as a Team Leader in the said BPO.

3...That at the time of marriage the father of the Complainant transferred Cash Rs.2,25,000/- to the joint account of parents of the accused No.1, and Rs. 60,000/- deposited in the Bank Account of the Accused No.1 (Husband) to purchase a bike as per demand of the accused persons named above. The father of the petitioner also provided golden ornaments around 15 Bhori, (150 Grms), furniture like Divan, Still Almirah, refrigerator, dressing table, etc. and other household utensils, dinner set made by steel and Kansha, etc. as per demand of the Accused Persons with a hope that her only daughter could start happy conjugal journey in her matrimonial house.

4...That the marriage is duly registered on 17/06/2021 before the Marriage Register Sri Robindranath Sardar in presence of witnesses as per Hindu Marriage Act at Purulia.

5...That soon after registration of marriage all the accused persons namely 1) Pradip Kumar Goswami 2) Anima Goswami 3) Biswajit Goswami 4) Mousumi Goswami asked the Complainant to bring back Rs. 2,00,000/- (Rupees two lacks ) from his father on the pretext to send her New Deli with Accused No-1, where he used to work .

6...That at the time of marriage all the accused persons fraudulently introduced Accused No-1 as Bank Manager of "HDFC BANK" but later on the petitioner came to know that her husband/ Accused No-1 was working as a Team Leader in a BPO.

7... That after marriage the Complainant came to her matrimonial house with a dream to start a happy conjugal journey at village- Dewandera, P.O. Dangal, P.S. Jhaida, District-Purulia, with a further dream to have new life with her husband/Accused No.1 at state capital of New Delhi.

8...That soon two month after her marriage the marital life of the Complainant become painful, she never accepted with love and dignity. From the outset of her marital life your Complainant fall victim of teasing and physical assault by all the accused persons for bringing in – adequate dowry. The caustic comments and the torture in way of both that is physical and mental by the Accused Persons – causes immense mental and physical pain, but the Complainant had to tolerate all such indignity and cruelty silently in lieu of extra demand of dowry money of Rs. 2,00,000/- from the father of the complainant.

9...That after marriage the Complainant was not even allowed to go her parental house at Cooks Compound, New Colony, P.O. Purulia, P.S. Purulia (T), District –Purulia, never

he allowed to talked to her parents over telephone, she was confined in a dirty room in her matrimonial house with door locked outside without proper food and clothing. He was never visited to any doctor for treatment when feel seek because of her father could not able to provide illegal extra demand of Rs. 2, 00,000/- (Rupees Two Lacks) to the Accused persons named above. The Complainant was also used to called as "BANJ" (Infertile lady) in her matrimonial house although the Accused No-1 never took her to any doctor, it is the Complainant who came to know from reliable source that her husband's sperm count is not up to the mark to gave birth of a baby but it is curable if he continues his treatment.

10...That when such state of thing is going on father of the Complainant died 23/12/2018, then the petitioner with the help of her mother for expenses to go New Delhi, she came to know that her husband (Accused No-1) never worked as a Bank Manager at HDFC Bank, rather he is working as a Team Leader in a BPO and having an illicit relationship with a lady from, Park Circus, Kolkata namely Musrat Begam. The accused No-1 adopted a practice to beat the complainant every night when he returns home in drunken position.

11...That on 7.09.2019 when the Complainant saw the Accused No-1 with an objectionable position then the petitioner opposed such relation, due to the same the Accused No-1 assaulted the Complainant mercilessly and ousted her forcefully from his New Delhi Apartment, the petitioner is a alone lady with the help of some local people managed to get train to Purulia in New Delhi Junction, and on 8/09/2019 after reaching Purulia she is leaving in the mercy of her widow mother at Cooks Compound, New Colony, P.O. Purulia, P.S. Puruia (T), District-Purulia.

12...That on 17.04.2021 all of a sudden Accused Persons visited the mother's house of Complainant at Cooks Compound, New Colony Purulia, and threaten her to transfer her share in the joint property, in the name of Accused No-1, where she along with the Complainant resides otherwise they will kill her and the Complainant. They also assaulted the petitioner's elderly ailing mother.

13...That on 12.11.2021 all the accused persons again visited the house of the mother of the petitioner namely Smritirekha Chatterjee W/O. Lt. Dilip Kumar Chatterjee at Cooks Compound, New Colony, P.O. Purulia, P.S. Purulia (T) and started to use abusive language to the petitioner and her elderly ailing mother and threaten them with dire consequences if the mother of the petitioner not transferred his share in the immovable property in the name of Accused No-1.

14... That your Complainant went to Purulia (T) P.S. on the same day to lodge a written complaint against the above named accused persons but the Officer on duty did not pay any heed to my written complaint. Hence on 15/11/2021 she sent his written complaint to the I.C. Purulia (T) P.S. through registered post but till date no action has been taken against the accused persons.
