I am to inform that one Under Trial Prisoner namely Muktipada Kumar S/o Lt. Anil Kumar, (JID No. 44-785-2021- UT) of Vill. Tilai, PS Balarampur, Dist Purulia, detained in Purulia DCH since 31/08/2021 in C/W S.C No 114/2021 arising out of Balarampur PS Case No: 78/2021 Dated 27.08.2021, GR- 154/2021 was admitted at Isolation Ward in Deben Mahato Government Medical College & Hospital, Purulia on 21/12/2021 at around 8.25 PM as a life saving measure. The said U.T.P Muktipada Kumar has absconded from lawful custody (police guard provided by Reserve Inspector, Purulia as per requisition vide this office memo no. 1993/AB dated 21/12/2021) at about 8.40 a.m on 22/12/2021 as informed from R. I, Purulia through e.mail at 15.33 hrs.

Under this circumstance, I am to request you to take necessary action in this regard. The letter may kindly be treated as F.I.R. regarding escaped of the said UTP (copy of e-Prisons history ticket along with photo of escaped prisoner is enclosed)


