Sir,

I, Sekhar Kr Mitra, Inspector of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles viz (i) 10 (Ten) Pcs domestic LPG cylinders of Indane company fully loaded with LPG & sealed condition, (ii) 05 (Five) Pcs domestic LPG cylinders of Bharat company fully loaded with LPG & sealed condition, (iii) 05 (Five) Pcs LPG empty cylinder of Indane Company, (iv) 01 (One) Pc LPG empty commercial cylinder of Indane company, (v) 02 Pcs LPG small empty cylinder of Indane company, (vi) 01 Pc Nozzle device (Size - 3 Inch approx) appearing to have been made of copper & steel used for re-filling gas from one to another cylinders, (vii) 01 (one) Electronic weight machine "Micro tech" to the effect that today on 27.12.2021 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, ASI Prabir Kr Mukherjee, W/C 88 Pradyut Mandal, HG/1427 Benimadhab Char all of DEB Purulia had been to Raghunathpur PS and submitted one requisition to IC Raghunathpur PS for rendering assistance for workout the credible information under the jurisdiction of Raghunathpur PS at 11.05 hrs. which has been noted in GD vide Raghunathpur PS GDE No. 1332 dtd. 27.12.2021 at 11.35 hrs. Thereafter we along with officer and force of Raghunathpur PS left for Bero village under Raghunathpur PS to work out the information. On arrival at Bero village at about 13.45 hrs to work out the information and holding raid, search and seizure in the house of one Sahadeb Gorain S/o Lt. Sitaram Gorain of Vill.- Bero, PS - Raghunathpur, Dist.- Purulia. Prior to holding raid in the house, we noticed huge nos. of domestic LPG cylinder kept inside the shop along with apparatus which is used for refilling LPG from one to another cylinder. The owner namely Sahadeb Gorain was asked to produce valid documents / license for running his business in respect of possessing such domestic LPG cylinders and also such business of refilling, but the owner failed to produce any valid documents / license for running such illegal business. Thereafter myself along with accompanied officers and force held raid in the house of Sahadeb Gorain S/o Lt. Sitaram Gorain of Vill.- Bero, PS - Raghunathpur, Dist.- Purulia, after observing all formalities relating to search and seizure in between 14.15 hrs to 15.25 hrs.

As such I seized the articles as noted above with proper labeling in presence of police witnesses under proper seizure list from the house of Sahadeb Gorain.

Sahadeb Gorain S/o Lt. Sitaram Gorain of Vill.- Bero, PS – Raghunathpur, Dist.-Purulia failed to produce any valid documents / papers for running such business hence he violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence he has committed an offence punishable u/s 7(i)(a)(ii) of E.C.Act 1955.

In course of local enquiry it revealed that said Sahadeb Gorain is running clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to Govt. The above noted seized articles as mentioned in S/L No. 1 to 5 left in Zimma to one office manager of Ratandip GAS Agency namely Ramprasad Karmakar S/o Khudiram Karmakar of Sanka, PS – Raghunathpur, Dist.- Purulia vide his dealer code no. 133991 situated at Rakshatpur village PS- Raghunathpur, Dist.- Purulia in anticipation of kind approval of the Ld. ACJM Raghunathpur Court, Purulia.

I therefore request you to start a case u/s 7(i)(a)(ii) of E.C.Act 1955 against accused Sahadeb Gorain S/o Lt. Sitaram Gorain of Vill.- Bero, PS – Raghunathpur, Dist.- Purulia.

As per kind order of Dy. SP(DEB), Purulia SI Amaresh Das of DEB, Purulia will investigate the case.
