Sub : Prayer for lodging FIR against accused Dhiren Gorain (58 yrs) S/O - Lt. Guhiram Gorain of Kanki Basti, PS-Santaldih, Dist- Purulia, U/S 46 A (c) Bengal Excise Act, 1909.

Sir,

In producing herewith one arrested accused person named as Dhiren Gorain (58 yrs) S/O - Lt. Guhiram Gorain of Kanki Basti, PS-Santaldih, Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 10.12.2021 at about 16.45 hrs I received a source information to the effect that the country spirit (Dil khush) has been kept at Kanki Bazar near STPS gate no. 1 under this PS in the shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for Kanki Bazar near STPS gate no. 1 to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the shop of Dhiren Gorain at Kanki Bazar near STPS gate no. 1 at about 16.55 hours. Seeing police party some unknown persons in front of the shop of Dhiren Gorain were fled away. However, I could detain one among of them and asked about his identity. He revealed his name and identify as above and as well as admitted that he gathered the country spirit (Dil khush) for selling and he was the owner of the said shop. However, I along with said accused started a search inside the shop of Dhiren Gorain and found the following item in the said shop -

1) 12 (Twelve) bottles 80UP country spirit (Dil khush) each bottles containing 600 ML market value of each being in total approx Rs. 600/ - (Six hundred only)

01 (one) bottle of 600 ML taken (Dil khush) out of the above as sample packet, labeled and sealed with sealing wax.

2) Sale Proceed cash of Rs.- 155/- (One hundred fifty five only)

I interrogated him about the purpose of the stocking and possessing country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 17.05 hrs and 17.50 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 17.55 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Dhiren Gorain (58 yrs) S/O - Lt. Guhiram Gorain of Kanki Basti, PS-Santaldih, Dist-Purulia.
