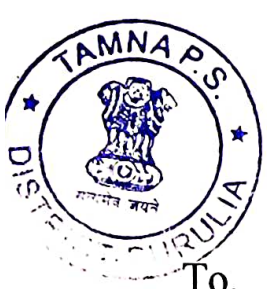

Respected Sir,

In producing herewith one arrested accused person namely Arun singh Sardar (34 yrs) S/O- Lt. Paban Singh Sardar of Vill- Dumursol, PO- Pichasi, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 30.12.2021 at about 05:45 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I ASI Gopal Hembram of Tamna PS along with force had been to Dumursol village under Tamna PS at 06:25 hrs and as per indication conducted raid in the house of Arun singh Sardar (34 yrs) S/O- Lt. Paban Singh Sardar of Vill- Dumursol, PO- Pichasi, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his house. As such I seized (i) One Plastic Jerican containing approx 10 (Ten) litres ID Liquor & (ii) one Plastic Bottle containing one litre ID Liquor taken from the Jerican for as a sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Arun singh Sardar (34 yrs) S/O- Lt. Paban Singh Sardar of Vill- Dumursol, PO- Pichasi, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Arun singh Sardar (34 yrs) S/O- Lt. Paban Singh Sardar of Vill- Dumursol, PO- Pichasi, P.S- Tamna, Dist.- Purulia.
