In producing herewith arrested accused person namely Dhananjoy Mudi (33 Yrs) S/O- Hablu Mudi of Vill- Nadiha, PS- Purulia (M), Dist- Purulia along with one seized one black colour Honda Dream Yoga Motor Cycle bearing Registration No- JH09AE/4565.

I, ASI Gopal Hembram beg to report that today myself along with C/1454 Ashoke Kr. Mahato & C/106 Maheswar Majhi all are of Tamna PS were performing Spl. Mobile duty at near Chengi more under Tamna PS area vide Tamna PS GDE No- 1329 Dtd- 30.12.2021 at about 15:55 hrs, I found one motor Cycle bearing Registration No- JH09AE/4565 coming from Simulia side rashly and negligently. We tried to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. Being asked to produce all relevant documents in respect of said Motor cycle he produced all document except Driving License regarding the seized Motor Cycle bearing Registration No- JH09AE/4565. So, I arrested the above noted accused person after observing all legal formalities regarding arrest as he violated Sec. 279 IPC and 181 MV Act. I also seized the motor cycle in presence of witnesses and informed his family members regarding ground of arrest.

Therefore I pray that a specific case may kindly be started against accused Dhananjoy Mudi S/O- Hablu Mudi of Vill- Nadiha, PS- Purulia (M), Dist- Purulia driver of Motor Cycle bearing Registration No- JH09AE/4565.
