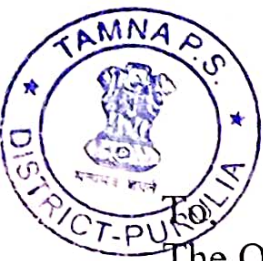

Respected Sir,

In producing herewith one arrested accused person namely Manoj Hembram (26 yrs) S/O- Hapan Hembram of Vill- Karamara Uparpara, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 10.12.2021 at about 04:25 hrs during special night mobile duty, received a secret source information and as per order of O/C Tamna PS, I SI Badal Paramanik of Tamna PS along with force had been to Karamara village under Tamna PS at 04:55 hrs and as per indication conducted raid in the house of Manoj Hembram (26 yrs) S/O- Hapan Hembram of Vill- Karamara Uparpara, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his house. As such I seized (i) Two white Plastic Jerican containing 05 (Five) liters ID Liquor, one liter taken from one Jerican for as a sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Manoj Hembram (26 yrs) S/O- Hapan Hembram of Vill- Karamara Uparpara, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Manoj Hembram (26 yrs) S/O- Hapan Hembram of Vill- Karamara Uparpara, P.S- Tamna, Dist.- Purulia.
