Ananda Mohan Patra beg to report that today myself along with C/138 Bani Bandopadhyay & NVF/1075 Dhananjay Rajak all are of Tamna PS were performing Special Naka Checking duty at Chengi more under Tamna PS area vide Tamna PS GDE No- 747 Dtd- 18.12.2021 at about 15:45 hrs. I found one motor Cycle bearing Registration No- JH10T/2660 coming from Damda side rashly and negligently. We try to stop him bat the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. Being asked to produce all relevant documents in respect of said Motor cycle he produced all document except Driving License.
