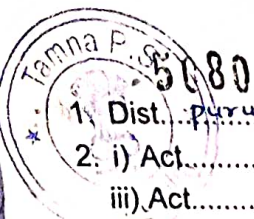

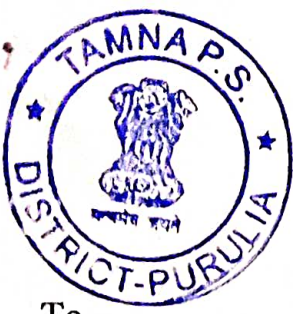

In producing herewith arrested accused person namely Chitta Mahato S/O- Lt. Banamali Mahato of Vill- Simulia Basti, PS- Tamna, Dist- Purulia along with one seized black colour Hero Splender plus Motor Cycle bearing Registration No- JH09AR/3824.

I, SI Hemanta Kr. Sahababu S/O- Lt. Madan Mohan Sahababu beg to report that today myself along with C/152 Paresh Nath Bauri & C/293 Subhasis Chakraborty all are of Tamna PS were performing day mobile duty at Tamna PS more under Tamna PS area vide Tamna PS GDE No- 407 Dtd- 10.12.2021 at about 12:45 hrs, I found one motor Cycle bearing Registration No- JH09AR/3824 coming from Purulia side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. Being asked to produce all relevant documents in respect of said Motor cycle he produced all document except Driving License. So, I arrested the above noted accused person after observing all legal formalities regarding arrest as he violated Sec. 279 IPC and 181 MV Act. I also seized the motor cycle in presence of witnesses and informed his family members regarding ground of arrest.

Therefore I pray that a specific case may kindly be started against accused Chitta Mahato S/O- Lt. Banamali Mahato of Vill Simulia Basti, PS- Tamna, Dist- Purulia.
