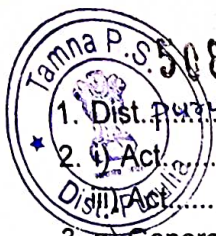

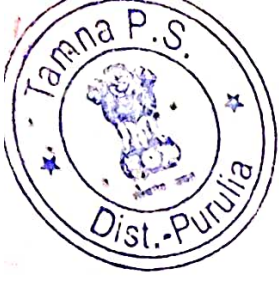

In producing herewith arrested accused person namely Md. Yunus Ansary S/O- Lt. Hakim Miyan of Vill- Harkatwatand, P.O- Keshwari, PS- Suriya Keshwari, Dist- Giridih, Jharkhand along with one seized black colour Hero Glamour Motor Cycle bearing Registration No- JH11S/1297.

I, SI Badal Paramanik of Tamna PS beg to report that today myself along with C/2614 & C/1509 Animesh Mukherjee all are of Tamna PS were performing Spl. day mobile duty at Tamna PS more under Tamna PS area vide Tamna PS GDE No- 400 Dtd- 10.12.2021 at about 13:25 hrs, I found one motor Cycle bearing Registration No- JH11S/1297 coming from Purulia side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be start against accused Md. Yunus Ansary S/O- Lt. Hakim Miyan of Vill- Harkatwatand, P.O- Keshwari, PS- Suriya Keshwari, Dist- Giridih, Jharkhand.
