Khagen Roy, of Vill- Lukuidih, P.O- Anai Jambaid, PS- Purulia (M), Dist- Purulia and lodge a written complaint against them, to the effect that on 10.12.2021 while myself along with force of Tamna PS as per direction engaged in PS Spl.
