Sir,

In producing herewith arrested accused person namely Kartik Bauri (20 yrs) S/O Takurlal Bauri of Adra near Ram mandir, Rly Market Chaigada, P.S- Adra, Dist- Purulia along with seized articles (1) One dark colour Hung Motor Cycle Hero Honda reg no- WB-56F-2959.

I beg to report that today myself along with C/245 Rabin Rajak and C/1455 Sudhansu Kuiry both of Adra PS were performing special mobile duty at Chanta More under Adra PS, vide Adra PS C.C No-75/22 dtd.07/01/2022 and Adra PS GDE No-286. At about 16:55 hrs, I found one dark colour Hung Motor Cycle Hero Honda reg no- WB-56F-2959 coming from Ram mandir more side towards Chatna more side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about 17:05 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 184 MV Act 1988 in presence of police party. As the place is lonely so there is no public present at that time. The whole process of seizure was completed in between 17:05 hrs to 17:35 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused Kartik Bauri (20 yrs) S/O Takurlal Bauri of Adra near Ram mandir, Rly Market Chaigada, P.S- Adra, Dist- Purulia.
