**Sir,**

In producing herewith one arrested accused persons namely Goutam Gope (26 Yrs) S/O- Jagannath Gope of Vill-Buridih, PS- Purulia (M), Dist- Purulia (Driver of vehicle No- JH 10G/2585 along with seized one Red Colour Truck (10 Wheeler) bearing registration No- JH 10G/2585 loaded with stone (Quartz) of 30 MT (Approx) out of them 01 kg seized as sample and original Driving License of driver Goutam Gope vide D/L No- WB 55 2018 0040412

I do hereby lodge a complaint to the effect that on 11.01.2022 I, PLSI Iti Neogi, along with C/568 Madhusudan Rajwar and C/1119 Susanta Kumar Sinha all are of Adra PS were engaged in Night Mobile duty vide Adra PS CC No- 106/22 Dt. 11.01.22. In course of night Mobile duty, at about 22:25 hrs received credible source information that one truck bearing registration No- JH 10G/2585 loaded with stone coming from Raghunathpur side procuring illegally and trying to transport the same to Kashipur side through Adra - Kashipur road in clandestine manner. I immediately intimated you over phone and acquainted you about the information and you directed me to work out the information. In the mean time at about 22:35 hrs found that the above noted vehicle was coming from Raghurathpur side. We indicated the vehicle to stop on Adra-Kashipur pitch road near Ranguni More and on checking it was found that the vehicle was matched given by source and found that approx 30 MT of Stone (Quartz) is loaded inside of the vehicle. Then I requested the driver to produce relevant documents/Challan/cash memo in respect of loaded stone but he failed to produce any valid documents in support of loaded Stone as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle have procured said Stone from different illegal source under Jharkhand state.

So, it is reasonable to believe that the above noted accused driver, registered owner of the said vehicle have obtained the Stone either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same stone in a clandestine manner to Kashipur side knowing it to be stolen, as per their regular practice.

Accordingly, I seized one Red Colour Truck (10 Wheeler) bearing registration No- JH 10G/2585 loaded with stone (Quartz) of 30 MT (Approx) and original Driving License of driver Goutam Gope vide D/L No-WB 55 2018 0040412 under proper seizure list duly signed by available witnesses and also I arrested Goutam Gope (26 Yrs) S/O- Jagannath Gope of Vill-Buridih, PS- Purulia (M), Dist- Purulia (Driver of vehicle No- JH 10G/2585) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded Truck.

Under the above circumstances a specific case may kindly be started against (1) Goutam Gope (26 Yrs) S/O- Jagannath Gope of Vill-Buridih, PS- Purulia (M), Dist- Purulia (Driver of vehicle No- JH 10G/2585) (2) Registered owner of vehicle having No- JH 10G/2585 under proper sections of law.
