I am producing herewith following arrested accused persons namely i) Anup Rajwar (34Y) S/o- Paran Rajwar of Vill- Sirkabad, PS- Arsha, Dist- Purulia, ii) Rajesh Kr. Majhi (22Y) S/o- Dwija Pada Majhi of Vill- Sirkabad, PS- Arsha, Dist- Purulia, iii) Bijoy Bauri (38Y) S/o- Kamal Bauri of Vill- Bagda, PS- Pancha, Dist- Purulia, A/P Sirkabad BPHC Compound, iv) Shubnath Karmakar (32Y) S/o- Lt. Ghasiram Karmakar of Vill- Sirkabad , PS- Arsha, Dist- Purulia. v) Majbur Ansary @ Bhandu (28Y) S/o- Abul Majim Ansary of Vill- Sirkabad , PS- Arsha, Dist- Purulia. I beg to submit that on 09.01.2022. I received information that at Sirkabad Dungri gora a cock fighting was going on where huge gathering were there. Accordingly I inform the matter to O/C Arsha PS and myself along with force left to work out the information vide GDE No 333/22 Spl. CC No. 01/22. Dtd.09.01.2022. After reaching at Sirkabad Dungri gora I found approx 150/200 people gathered at this place and cock fighting was going on. Seeing the police party the spectators fled away but I managed to apprehend the above noted persons i) Anup Rajwar (34Y) S/o- Paran Rajwar of Vill- Sirkabad, PS- Arsha, Dist- Purulia, ii) Rajesh Kr. Majhi (22Y) S/o- Dwija Pada Majhi of Vill- Sirkabad, PS- Arsha, Dist- Purulia, iii) Bijoy Bauri (38Y) S/o- Kamal Bauri of Vill- Bagda, PS- Pancha, Dist- Purulia, A/P Sirkabad BPHC Compound, iv) Shubnath Karmakar (32Y) S/o- Lt. Ghasiram Karmakar of Vill- Sirkabad , PS- Arsha, Dist- Purulia. v) Majbur Ansary @ Bhandu (28Y) S/o- Abul Majim Ansary of Vill- Sirkabad , PS- Arsha, Dist- Purulia. I arrest them observing all formalities. As they violated the Govt. order during their covid-19 protocol pandemic situation. On interrogation they stated that i) Sisir Bagti S/o- Harkhu Bagti of Vill- Sirkabad, PS- Arsha, Dist- Purulia, ii) Charu Bauri @ Gora S/o- Suku Bauri of Vill- Sirkabad, Arsha, Dist- Purulia, are organized of the said cock fighting programme. They also present at this programme and they fled away. On being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during these Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 17.05 hrs to 17:25 hrs and brought to PS (vide Order No. 753/XVII-ISS/2M-22/2020 Dtd. 02.01.2022).

So all the persons have committed offence U/S 188/34 IPC & 51(i) (b) of the National Disaster Management Act 2005. So I request you for starting a case and also arrange for its investigation.
