Respected Sir,

I am producing herewith following arrested accused persons for the fact that, today (20.01.2022) during my special mobile duty (Arsha PS GDE No. 709/22 dtd. 20.01.2022) with (i) C/1140 Dayamay Mahato (ii) C/694 Nekibuddin Khan and (iii) C/- 1516 Arnab Sinha all of Arsha PS, vide Arsha PS C.C No. 08/22 dtd 20.01.2022 had been at Sirkabad Bus-stand and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all of them violated the Govt. Order during these Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all were arrested between 17.15 hrs to 18:00 hrs and brought to PS (vide Order No. 753/XX-ISS/2M-22/2020 Dtd. 15.01.2022).


