Kailash Kumar (27 Yrs), S/O- Bishnu Kumar of Vill- Bhurshu, all of PS- Baghmundi, Dist-Purulia to the effect that on 03.01.2022 while I SI Snehasish Mondal of Baghmundi PS along with force 1) C/841 Tukai Ghosh, 2) C/Mustakfijur Mondal both of SAP 11<sup>th</sup> Bn. camp at Baghmundi PS, Dist-Purulia were performing special mobile duty vide Baghmundi GDE No- 71, Dated- 03.01.2022 & C.C. No- 20/22, dtd- 03.01.2022. During my special mobile duty when myself along with force reached at Ajodhya More on Baghmundi-Balarampur Main Road at about 18:15 hrs and found above persons were roaming aimlessly at Ajodhya More Area without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Memo No- 753/XVII- ISS/2M- 22/2020, dtd- 02.01.2022.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request. So I arrested them in between 18:25 hrs to 19:55 hrs for violating the section of Disaster Management Act 2005 after maintaining all arrest related guidelines and rules.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
