

3. Date of Occurrence :- From the very inception of Marriage i.e. 28-04-2016, corresponding to 15th. Baisakh 1423 B.S. and on wards in her matrimonial house and particularly on 25-06-2021 at village Suisa under P.S. Baghmundi, District Purulia which is still continuing.





4. Offences:- U/S 498A/323/326/34 I.P.C & 3 and 4 Dowry Prohibition Act. .

The above named petitioner begs to state as follows:-

1---- That your petitioner is the legally married wife of accused Sudhir Saw .The parties are Roniar Banik by caste and Hindu by religion . Their marriage was solemnised on 28-04-2016 , according to their customary rites and formalities prevalent in their community . Their marriage was duly consummated and the marriage tie between them still in subsistence .

2----That accused Sudhir Saw is her husband, accused Saligram Saw and Raj Kumari Saw are her parent in laws, accused Manoj Saw is her Bhansur and accused Sushama Saw is her Jethani.

3----That at the time of her marriage, as per demand by the accused persons , circumstances and social evils brothers of the complainant had to give considerable dowry including a hard cash of Rs. 1.30,000/-.utensils , ornaments and house hold articles were given to the accused persons by selling agricultural lands but the accused persons were not satisfied with the same .


4----That after marriage your petitioner had been to her matrimonial home started to live there as husband and wife for 10/12 days and there after her husband at the ill advice of his parent , elder brother and elder Jethani started a fresh demand of Rs. 100,000/- and asked her to bring the same from her brothers . Your petitioner politely told to her matrimonial members that every body knows that her poor brothers had gave every thing to them as settled on marriage negotiation and they became a pauper . At this all the accused persons threatened the petitioner that she must convey their demand to brothers otherwise she has no place in their house . Accordingly your petitioner conveyed the fresh demand to her poor brothers who were very much surprised and shocked by hearing such huge amount and expressed their inability to meet the fresh demand .

5----That when the money as demanded by the accused persons could not be fulfilled by her poor brothers, all the accused persons were became furious and vindictive upon her and strted various mental and physical torture upon her . She was denied to square meal by accused Raj Kumari Saw and Suahama Saw , Her husband and Nandai played a tactic role and snatched away her mobile phone from her and put out the Sim Card from the mobile and return the Sim Cardless mobile to her . After 3/4 days her husband , Bhansur and Nandai asked her why she has talk with another boy over mobile phone ? Your petitioner politely told her husband and others that she never talk with other as the Sim Card has been put out from her mobile by them . Then her husband, at the instigation of her Bhansur Manoj Saw and Nandai started to assault the petitioner mercilessly . By such merciless beating one of her teeth has been broken and after severe assault she was driven out from her matrimonial home by all the accused persons .The accused persons treated the petitioner as a unpaid maid servant and compelled her to do the entire work of the family from dusk to dawn . Being a devoted Hindu wife she bears those torture, assault and cruelty on the hope that her husband and other in laws would mend their attitude and would be normal towards her but her hopes were never materialised .

6----That after waiting for some time , her mother and brothers again reached her to her matrimonial home but the accused persons started to assault the petitioner and drove her out again . The accused persons times without number come to her father's house at village Suisa and demand the additional dowry and threatened her that if the money is not give to them they did not took her to their house and openly threatened that her husband would contract second marriage with another girl which would ensure them further lucrative dowry ,

7----That on 25/06-2021, her husband Sudhir Saw along with his father, elder brother and husband, his wife Sushama Saw, husband of her husband's sister (Nandai) have come to her father's house at Suisa village and pressurised her to put her signature on a paper of divorce. When the petitioner denied to sign on that paper of Divorce the her husband, father in law, elder brother in law, Jethani and Nandai became furious and started to assault the petitioner in presence of her brothers and mother and threatened that her husband would filed Divorce Suit against her very soon. They advised the petitioner to commit suicide in her father's house a under compulsion your petitioner took shelter in her father's house at village suisa under Baghmundi Police Station.

8----That your petitioner has reported the ordeal faced by her in her matrimonial home as well as in her father's house caused by the accused persons before the local Police Station but the police did not pay any heed to the complainant . Finding no other alternative , your petitioner knocked the door of the Superintendant of Police Purulia on 29-12-2021, but his good office also did nothing .

9----That your petitioner is a helpless, poor woman having no source of income. She is in acute distress and poverty and not in a position to conduct the case in her own costs. More over there are some legal and technical aspect involved in the matter which can not be responded in a complaint oriented case. So a thorough police investigation is required in this matter & a police case is highly desirable

It is prayed that your honour may be graciously pleased to direct the O/C Baghmundi P.S. to investigate the case according to law , treating the same as F.I.R . as contemplated U/S 156(3) Cr.P.C.
